Dialogic® Pro™ Host Media Processing (HMP) Maintenance is transitioning to Dialogic® Pro™ Value Per Unit Plan (VPUP) service in order to provide more consistent service offerings across Dialogic® software products. Full, official details and dates of transition are reflected in the associated Product Change Notification (PCN), which is reproduced below as *Appendix A*.

Following the transition, VPUP service will be available at the time of initial purchase of the associated Dialogic HMP Software product.

This transition allows customers to receive services as part of the VPUPs that are in addition to what was previously offered as part of HMP Maintenance, with no price difference. These additional VPUP features include:

- Technical support covering installation, configuration and deployment
- Business hours remote technical support direct from Dialogic
- Software maintenance

Beginning August 6, 2010, when purchasing service contracts for Dialogic® HMP Software via the Dialogic Product Center, customers will have the option to order either the 1 year or 3 year Value Per Unit Plan (VPUP) (“Migration Product”) instead of the Discontinued Product..

Product Center will change to automatically calculate the VPUP Service fee based on the HMP product configuration and display the service fee in US dollar values. The current Maintenance calculation displays a variable quantity of Maintenance units at a fixed dollar amount. As of the PCN availability date, Product Center will calculate the VPUP at quantity of 1 at variable dollars (based on the configuration).

Product Center will default to including a VPUP with every order. Customers will need to deselect the VPUP if they are not interested in purchasing it.
